

Full Environmental Assessment Form
Part 2 - Identification of Potential Project Impacts

Part 2 is to be completed by the lead agency. Part 2 is designed to help the lead agency inventory all potential resources that could be affected by a proposed project or action. We recognize that the lead agency's reviewer(s) will not necessarily be environmental professionals. So, the questions are designed to walk a reviewer through the assessment process by providing a series of questions that can be answered using the information found in Part 1. To further assist the lead agency in completing Part 2, the form identifies the most relevant questions in Part 1 that will provide the information needed to answer the Part 2 question. When Part 2 is completed, the lead agency will have identified the relevant environmental areas that may be impacted by the proposed activity.

If the lead agency is a state agency **and** the action is in any Coastal Area, complete the Coastal Assessment Form before proceeding with this assessment.

Tips for completing Part 2:

- Review all of the information provided in Part 1.
- Review any application, maps, supporting materials and the Full EAF Workbook.
- Answer each of the 18 questions in Part 2.
- If you answer “**Yes**” to a numbered question, please complete all the questions that follow in that section.
- If you answer “**No**” to a numbered question, move on to the next numbered question.
- Check appropriate column to indicate the anticipated size of the impact.
- Proposed projects that would exceed a numeric threshold contained in a question should result in the reviewing agency checking the box “Moderate to large impact may occur.”
- The reviewer is not expected to be an expert in environmental analysis.
- If you are not sure or undecided about the size of an impact, it may help to review the sub-questions for the general question and consult the workbook.
- When answering a question consider all components of the proposed activity, that is, the “whole action”.
- Consider the possibility for long-term and cumulative impacts as well as direct impacts.
- Answer the question in a reasonable manner considering the scale and context of the project.

The Village Board of Trustees reviewed all the questions in Part 2 of the Full Environmental Assessment Form and did not identify any potentially small, moderate or large environmental impacts as a result of the adoption of an addendum to the 2007 Village of Briarcliff Manor Comprehensive Plan replacing and updating recommendations related to the B Planned Office Building and Laboratory District and the BT Business Transitional District. In addition, the Village Board of Trustees reviewed the criteria listed in Section 617.7 of the SEQRA law.

(1) To determine whether a proposed Type I or Unlisted action may have a significant adverse impact on the environment, the impacts that may be reasonably expected to result from the proposed action must be compared against the criteria in this subdivision. The following list is illustrative, not exhaustive. These criteria are considered indicators of significant adverse impacts on the environment:

- (i) a substantial adverse change in existing air quality, ground or surface water quality or quantity, traffic or noise levels; a substantial increase in solid waste production; a substantial increase in potential for erosion, flooding, leaching or drainage problems;*

The proposed action is adoption of an addendum to an existing community plan, not a construction or infrastructure project. Therefore this criterion is not applicable.

- (ii) the removal or destruction of large quantities of vegetation or fauna; substantial interference with the movement of any resident or migratory fish or wildlife species; impacts on a significant habitat area; substantial adverse impacts on a threatened or endangered species of animal or plant, or the habitat of such a species; or other significant adverse impacts to natural resources;*

The proposed Comprehensive Plan Addendum is intended to promote protection of vegetation, wildlife, habitat areas and other natural resources. No adverse impacts to these resources are anticipated from adoption of the Addendum.

- (iii) the impairment of the environmental characteristics of a Critical Environmental Area as designated pursuant to subdivision 617.14(g) of this Part;*

None of the B or BT District properties are located within a Critical Environmental Area; therefore, this criterion is not applicable.

- (iv) the creation of a material conflict with a community's current plans or goals as officially approved or adopted;*

The proposed Comprehensive Plan Addendum is consistent with the Village's adopted plans and policies and is intended to promote a pattern of land use consistent with the existing Village context and supportable by existing infrastructure.

- (v) the impairment of the character or quality of important historical, archeological, architectural, or aesthetic resources or of existing community or neighborhood character;*

The proposed Comprehensive Plan Addendum is intended to promote protection of important historical, archeological, architectural or aesthetic resources and existing community and neighborhood character. No adverse impacts to these resources are anticipated from adoption of the Addendum.

(vi) *a major change in the use of either the quantity or type of energy;*

The proposed action is adoption of a community plan, not a construction or infrastructure project. Therefore this criterion is not applicable.

(vii) *the creation of a hazard to human health;*

The proposed action is adoption of a community plan, not a construction or infrastructure project. Therefore this criterion is not applicable.

(viii) *a substantial change in the use, or intensity of use, of land including agricultural, open space or recreational resources, or in its capacity to support existing uses;*

The proposed Comprehensive Plan Addendum specifically calls for the preservation of onsite open space and the provision of additional recreational amenities to the benefit of Village residents if and when properties located within the B/BT District are redeveloped.

(ix) *the encouraging or attracting of a large number of people to a place or places for more than a few days, compared to the number of people who would come to such place absent the action;*

The proposed action is adoption of a community plan, not a construction or infrastructure project. Therefore this criterion is not applicable.

(x) *the creation of a material demand for other actions that would result in one of the above consequences;*

The proposed action is adoption of a community plan, not a construction or infrastructure project. Therefore this criterion is not applicable.

(xi) *changes in two or more elements of the environment, no one of which has a significant impact on the environment, but when considered together result in a substantial adverse impact on the environment; or*

The Village Board of Trustees has considered the various potential elements of the environment identified in Section 617.7(c), and does not envision any combined impacts resulting in a substantial adverse impact on the environment.

xii) *two or more related actions undertaken, funded or approved by an agency, none of which has or would have a significant impact on the environment, but when considered cumulatively would meet one or more of the criteria in this subdivision.*

The Village Board of Trustees is not aware of any other action, when undertaken with this one, which would result in a cumulative negative impact on the environment.
